BOR RESOLUTION NO. 28, s. 2010

A RESOLUTION CONFIRMING THE CANDIDATES FOR GRADUATION FROM THE MAIN CAMPUS AND THE ALANGALANG CAMPUS FOR THE SUMMER, SY 2009-2010

WHEREAS, Section 4, Paragraph (j) of R.A. 8292 empowers the Governing Board "to set policies on admission and graduation of students";

WHEREAS, Section 10 of Republic Act No. 8292 – The Academic Council - stipulates the powers of the Academic Council to wit: "... It shall fix the requirements for the admission of students as well as for graduation and the conferment of degrees, *subject to* review and/or approval of the Board of Regents/Trustees through the President of the university or college";

WHEREAS, Item c of Section 39 of CHED Memorandum No. 3, s. 2001 dated 21 January 2001 stipulates, to wit: "Fix the requirements for the admission of students in the concerned chartered SUC as well as for their graduation and the conferment of degrees and submit the same to its GB for review and/or approval in accordance with Section 4, Paragraph (j) of R.A. 8292";

WHEREAS, the University Academic Council has reviewed the list of candidates for graduation from the Main Campus for the Summer, SY 2009-2010 by Referendum last 07 June 2010 and has recommended the same to the VSU Board of Regents for Confirmation, *Provided That*, all the candidates have complied with all the requirements for graduation on or before the deadline indicated in the approved Academic Calendar for School Year 2009-2010.

THEREFORE, BE IT RESOLVED AS IT IS HEREBY RESOLVED to approve the list of candidates for graduation from the Main Campus and the Alangalang Campus for the Summer, SY 2009-2010 *Provided That* all the candidates have complied with all the requirements for graduation on or before the deadline indicated in the approved Academic Calendar for School Year 2009-2010.
