**A RESOLUTION APPROVING  
THE REQUEST OF DR. CONCHITA A. ITO  
DEAN OF THE LSU VILLABA CAMPUS FOR A  
P 111,000.00 CASH ADVANCE AS HUMANITARIAN AID TO  
VICTIM OF VEHICULAR ACCIDENT INVOLVING LSU-VILLABA VEHICLE**

**WHEREAS**, the LSU-Villaba Campus is the registered owner of two (2) registered vehicles: one (1) unit Isuzu pick-up; and one (1) unit Nissan Shuttle;

**WHEREAS**, LSU-Villaba Campus has in its employ a Mr. Gerry Cueva, whose main responsibility is to drive the official vehicles of the college during official travels of its faculty and staff;

**WHEREAS**, the Nissan Shuttle vehicle driven by Mr. Gerry Cueva was dispatched from the LSU Villaba campus last 29 April 2006 bound for Tacloban City to meet Dr. Conchita A. Ito at the Tacloban Airport;

**WHEREAS**, the said vehicle figured in a freak road accident at Brgy. Balud, Capoocan, Leyte involving a person on board a bicycle that resulting in severe head injuries to the victim necessitating his immediate operation and confinement at the Bethany Hospital in Tacloban City, Leyte;

**WHEREAS**, the medical expenses of the victim has already reached P 200,000 before he died;

**WHEREAS**, the GSIS Insurance pays victims of road accidents a maximum of P50,000 for serious cases;


**WHEREAS**, the University Administration is aware of the need to provide immediate humanitarian aid to the victim's family to pay for his medical and burial expenses and has strongly endorsed the request of the College Dean for final review and approval by the LSU Board of Regents.


**THEREFORE, BE IT RESOLVED AS IT IS HEREBY RESOLVED** to approve the request to of Dr. Conchia A. Ito for a P 111,000 Cash Advance as Humanitarian Aid to the Victim's Family Charged to Available College Income effective upon Board approval.
