Now, it has been pointed out that the College does not have a policy on secondment but secondment is a common practice of government schools and offices, there must be somewhere, general rules with Civil Service, Dept. of Labor and others. So Madam President, can you tell us about Mr. Tabada, where is he right now?

DR. P. MILAN:

Actually, Engr. Tabada was one of our GTZ scholar. He is supposed to finish computer science degree program but he could not finish within the time frame so he came back and reported to duty. When Dr. Ponce was seconded in DA BAR, he needed an expert in software program in his research and he identified Engr. Tabada as one of those who can do it. Because Engr. Tabada was on leave without pay during the last year of his study, so he thought it is a chance for him to do his dissertation and at the same time work with DA BAR with the understanding that DA BAR will pay his salary. So the Academic Personnel Board approved his secondment to DA BAR on Nov. 1, 1999.
