A RESOLUTION CONFIRMING THE RE-EMPLOYMENT OF MS. NELFA M. GLOVA AS MEDIA PRODUCTION SPECIALIST II IN THE MAIN CAMPUS SUBJECT TO EXISTING RULES, REGULATIONS AND GUIDELINES GOVERNING SUCH AN APPOINTMENT

WHEREAS, the Leyte State University was created by virtue of Republic Act 9158 which converted the then Visayas State College of Agriculture (ViSCA) into a state university last 11 August 2001 which was later renamed Visayas State University (VSU) by virtue of R.A. 9437;

WHEREAS, Section 7 of R.A. 9158 specifically empowers the Board of Regents of the University to exercise all the powers granted to the Board of Directors of a corporation under Section 36 of Batas Pambansa Blg. 68, otherwise known as the Corporate Code of the Philippines;

WHEREAS, among other powers granted to the Board of Regents is the power "to fix and adjust salaries of faculty members and administrative officials and employees ..." as stipulated in Section 7, Item (h) of R.A. 9158;

WHEREAS, the position of Media Production Specialist II became vacant with the resignation of Ms. Marites Sales who left permanently for the United States to pursue her graduate studies;

WHEREAS, Ms. Glova has been sitting in the said vacant position for the past seven years;

WHEREAS, Ms. Glova went on leave-without-pay (LWOP) last August 2009 when she left for the United States to pursue her graduate degree from the Michigan State University, United States of America;

WHEREAS, Ms. Glova graduated last May 2011 and immediately reported back to the University and requested for immediate reinstatement to her former position;

WHEREAS, the Non-Academic Personnel Board (NAPB), the Selection and Promotion Board for Administrative Personnel of the Visayas State University, has determined that the aforementioned employee is very well qualified for the vacant plantilla item and issued NAPB Resolution No. 21, s. 2011 dated 17 June 2011;

Glova with the issuance of an appointment for the vacant position of Media Production Specialist II in the Main Campus and is endorsing the same to the Board of Regents for Confirmation subject to existing rules, regulations and guidelines governing such appointments; and

WHEREAS, the Governing Board, is convinced that the recommendations of the NAPB and the University President is fair and adheres to thrust of government that only the best and the most fit should be in the government service.

THEREFORE, BE IT RESOLVED AS IT IS HEREBY RESOLVED to Confirm the re-employment of Ms. Nelfa M. Glova with the issuance of an appointment to her former position of Media Production Specialist II *subject to* existing rules, regulations and guidelines governing such appointments
