**BAC RESOLUTION RECOMMENDING TO THE HOPE TO AWARD THE SUPPLY
AND DELIVERY OF ONE UNIT GENERATOR SET (GOODS-20-07)**

**BAC Resolution No. 06

WHEREAS, the VISAYAS STATE UNIVERSITY through its Bids and Awards Committee posted on 19 January 2020 in the PhilGEPS, VSU Website's Transparency Seal and in conspicuous places within the premises of the Visayas State University an Invitation to Bid for the Supply and Delivery of **one (1) unit GENERATOR SET (GOODS-20-06)** with a total Approved Budget Contract of **One Million Five Thousand Pesos (Php1,005,000.00)**;

WHEREAS, the source of funds was from General Fund and allotted for the Project entitled "Innovation and Advanced Technology Program for Region VIII;

WHEREAS, on 10 February 2020, three (3) bidders submitted their bids: Simblante's Enterprises, Megamight Enterprises, and Fil Power Group & Marketing Corporation;

WHEREAS, upon checking their submitted Legal / Financial Documents and also their respective Technical Documents, the three bidders were rated passed and qualified to join the bidding;

WHEREAS, the source of funds was from GAA of 2020 and to be used in the Project entitled "Innovation and Advanced Technology al/ Financial Documents and their respective Technical Documents, all three bidders were rated passed and qualified to join the bidding;

WHEREAS, after ascertaining the bids and ranked, the BAC identified the **Lowest Calculated Responsive Bid (LCRB)** as shown below:

NOW, THEREFORE, We the Members of the Bids and Awards Committee, hereby **Resolve**, as it is hereby **RESOLVED**:

- a) To declare Fil Power Group & Marketing Corporation has the Lowest Calculated Bid for the Generator Set;
- b) To recommend to the HOPE of the Visayas State University the forgoing findings.
