#### **A RESOLUTION APPROVING THE NEW APPOINTMENT TO VACANT ITEM ADMINISTRATIVE POSITIONS**

**THEREFORE, BE IT RESOLVED AS IT IS HEREBY RESOLVED** to approve the new appointments of the following personnel:


