A RESOLUTION AMENDING SPECIAL BOR RESOLUTION NO. 3, s. 2009 APPROVING THE ALLOCATION OF FUNDS IN SUPPORT OF ALL EXTRAORDINARY EXPENSES TO BE INCURRED BY THE SPECIAL BOARD OF REGENTS' FACT FINDING COMMITTEE

WHEREAS, the Faculty Regent of the Visayas State University, on behalf of the VSU Faculty Association, has filed a series of complaints against one of the University's former employee with the Board of Regents;

WHEREAS, the former University employee has filed his application for the request the conferment of the position of *Professor Emeritus*, now that as he is no longer connected with the University;

WHEREAS, Section 7, Paragraph (a) of Republic Act No. 9158 empowers the Governing Board "to enact rules and regulations, not contrary to law, as may be necessary to carry out the purposes and functions of the University";

WHEREAS, the VSU Governing Board (GB) has decided to come up with a Special Fact-Finding Committee composed of three (3) persons who are in no way connected to the VSU and the appointment of the VSU Board Secretary as the Committee Secretary, to compose the Fact-Finding Committee tasked to investigate the alleged transgressions of its former employee, while he was still in the service;

WHEREAS, the GB has decided that all members of the Special BOR Fact Finding Committee including the Secretariat, be provided with funds for necessary extraordinary expenses attendant to its investigation including travel expenses, food, lodging as well as the grant of monetary incentive upon the submission of the Report to the Board of Regents, as follows:

Committee Chairperson - P 15,000.00 Committee Members - P 13,000.00 Board Secretary - P 12,000.00

THEREFORE, BE IT RESOLVED AS IT IS HEREBY RESOLVED to amend Special BOR Resolution No. 3, s. 2009 and approve the allocation of P60,000.00 to be used in support of all extraordinary expenses attendant to its investigation including travel expenses, food, lodging as well as the grant of monetary incentive to the Committee Chairperson, Committee Members and the Board Secretary, as proposed.
