BOR RESOLUTION NO. 95, s. 2011

A RESOLUTION APPROVING THE REQUEST OF PRESIDENT JOSE L. BACUSMO FOR AUTHORITY TO TRAVEL TO HOHENHEIM, GERMANY FOR SCIENTIFIC EXCHANGE MEETINGS WITH RESEARCHERS OF THE UNIVERSITY OF HOHENHEIM FROM 14 NOVEMBER 2011 TO 12 DECEMBER 2011 PROVIDED THAT NO GOVERNMENT FUNDS WILL BE USED TO DEFRAY THE COST OF INTERNATIONAL TRAVEL AND SUBJECT TO EXISTING RULES AND REGULATIONS GOVERNING FOREIGN TRAVELS BY GOVERNMENT OFFICIALS

WHEREAS, the Leyte State University was created by virtue of Republic Act 9158 which converted the then Visayas State College of Agriculture (ViSCA) into a state university last 11 August 2001 which was later renamed Visayas State University (VSU) by virtue of R.A. 9437;

WHEREAS, Section 7 of R.A. 9158 specifically empowers the Board of Regents of the University to "exercise all the powers granted to the Board of Directors of a corporation under Section 36 of Batas Pambansa Blg. 68, otherwise known as the Corporate Code of the Philippines";

WHEREAS, among other powers granted to the Board of Regents is the power "to develop consortia and other forms of linkages with local governments, institutions and agencies, both public and private, local and foreign, in furtherance of the purposes and objectives of the University" as stipulated in Section 7, Item (s) of R.A. 9158;

WHEREAS, the Visayas State University (VSU) presently has academic tie-up with the University of Hohenheim, Hohenheim, Germany;

WHEREAS, Dr. Jose L. Bacusmo, President, Visayas State College of Agriculture has been invited by the Centre of Agriculture in the Topics and the Sub-Tropics of the University of Hohenheim;

WHEREAS, the DAAD (German Academic Exchange Service) will be supporting all the travel and living costs during their stay; and

WHEREAS, the University President is requesting that he be allowed to utilize University funds for his domestic travel for this purpose.
