**RESOLUTION APPROVING THE ADOPTION OF
PrEd 161 (ASSESSMENT OF STUDENT LEARNING 2)
OF THE NEW BEEd AND BSEd CURRICULA FOR ALL 2ND, 3RD AND
4TH YEAR STUDENTS UNDER THE OLD BEEd AND BSEd CURRICULA**

WHEREAS, the Leyte State University was created by virtue of Republic Act 9158 which converted the then Visayas State College of Agriculture (ViSCA) into a state university last 11 August 2001 and was later renamed Visayas State University (VSU) by virtue of R.A. 9437;

WHEREAS, Section 7 of R.A. 9158 specifically empowers the Board of Regents of the University to exercise all the powers granted to the Board of Directors of a corporation under Section 36 of Batas Pambansa Blg. 68, otherwise known as the Corporate Code of the Philippines;

WHEREAS, among other powers granted to the Board of Regents is the power "to approve the curricula, institutional programs and rules of discipline drawn by the administrative and academic councils as herein provided" as stipulated in Item (i), Section 7 of R.A. 9158;

WHEREAS, the Professional Regulations Commission (PRC) issued PRC Resolution No. 7, s. 2008 last June 2008 "requiring examinees of the Licensure Examination for Teachers (LET) starting in 2009 to have taken Assessment of Student Learning I and Assessment of Student Learning 2 (at three units/course)";

WHEREAS, the 2nd, 3rd and 4th Year BEEd and BSEd students under the old curricula have only taken one 3-unit course ProfEd 134 (Tests, Measurement and Evaluation) in the old curricula which is an equivalent course of PrEd 146 (Assessment of Student Learning 1) in the revised curricula.;

WHEREAS, the University Curriculum Committee has approved the offering of PrEd 161 (Assessment of Student Learning 2) as an additional course for all 2nd, 3rd and 4th Year BEEd and BSEd students under the old curricula, in order to satisfy the PRC requirement;

WHEREAS, the University Administrative Council unanimously approved the offering of PrEd 161 (Assessment of Student Learning 2) as an additional course for all 2nd, 3rd and 4th Year BEEd and BSEd students under the old curricula, in order to satisfy the PRC requirement on the occasion of its 72nd UADCO Meeting held last 19 September at the 2nd Floor of the Center for Continuing Education, VSU Main Campus, Visca, City of Baybay, Leyte.

THEREFORE, BE IT RESOLVED AS IT IS HEREBY RESOLVED to approve the adoption of PrEd 161 (Assessment of Student Learning 2) which will be taken by all 2nd, 3rd and 4th Year BEEd and BSEd students under the old curriculum, to satisfy PRC requirements.

**Proposal to ADOPT PrEd 161 (ASSESSMENT OF STUDENT LEARNING 2)
OF THE NEW BEED AND BSED CURRICULA FOR ALL 2ND, 3RD AND
4TH YEAR STUDENTS UNDER THE OLD BEED AND BSED CURRICULA**

Rationale:


The Professional Regulation Commission's (PRC) Resolution No. 07-series of 2008, requires examinees of the Licensure Examination for Teachers (LET) starting in 2009 to have taken Assessment of Student Learning 1 and Assessment of Student Learning 2 at three units each, which are subjects in the revised BEED and BSED curricula as mandated by CHED Memo Order 30, series of 2004. The existing fourth year, third year and second year students of the Department of Science of Education have only one 3-unit course in ProfEd 134 (Tests, Measurement and Evaluation) in the old curricula, which is an equivalent course of PrEd 146 (Assessment of Student Learning 1) in the revised BEED and BSED curricula, hence, this proposal to comply with the PRC requirement.

Proposal:

Course Number	: PrEd 161
Descriptive Title	: Assessment of Student Learning 2
Course Description	: Development and utilization of alternative forms of assessment in measuring authentic learning.
Prerequisite	: ProfEd 134 (Tests, Measurement and Evaluation/ Assessment of Student Learning 1)

For fourth year BEED and BSED students, this course will be enrolled in the second semester of this school year 2008-2009, while for second year and third year BEED and BSED students, it will be enrolled in Summer of 2010 and 2009, respectively.


