A RESOLUTION APPROVING THE WORKLOAD UNITS GIVEN TO IGP MANAGERS

WHEREAS, the Leyte State University was created by virtue of Republic Act 9158 which converted the then Visayas State College of Agriculture (ViSCA) into a state university last 11 August 2001 and was later renamed Visayas State University (VSU) by virtue of R.A. 9437;

WHEREAS, Section 7 of R.A. 9158 specifically empowers the Board of Regents of the University to exercise all the powers granted to the Board of Directors of a corporation under Section 36 of Batas Pambansa Blg. 68, otherwise known as the Corporate Code of the Philippines;

WHEREAS, among other powers granted to the Board of Regents is the power "to enact rules and regulations, not contrary to law, as may be necessary to carry out the purposes and functions of the University" as stipulated in Item (a), Section 7 of R.A. 9158;

WHEREAS, the University Administrative Council discussed and approved the proposed guidelines in giving workload units to managers of income generating projects (IGPs) in its 76th UADCO Meeting held last 11 June 2009 and has recommended the approval of such guideline by the VSU Board of Regents;

THEREFORE, BE IT RESOLVED AS IT IS HEREBY RESOLVED to approve the proposed guidelines in giving workload units to managers of income generating projects (IGPs) as proposed.
