**A RESOLUTION APPROVING BAC RESOLUTION NO. CB-21 SERIES OF 2023 – A BAC RESOLUTION DECLARING HANDLINK, INC. AS THE BIDDER WITH THE LCRBs PER ITEM AND RECOMMENDING APPROVAL FOR THE VSU BOARD OF REGENTS THE AWARD AND CONTRACT TO THE SAID BIDDER WITH THE TOTAL AMOUNT OF P5,556,826.62 FOR THE PROJECT SUPPLY AND DELIVERY OF I.T. EQUIPMENT FOR THE ENHANCEMENT OF VICARP AND CMIs ICT CONNECTIVITY INFRASTRUCTURE (VSU-GOODS-23-23)**

**WHEREAS**, the Leyte State University was created by virtue of Republic Act 9158 which converted the then Visayas State College of Agriculture (ViSCA) into a state university last 11 August 2001 which was later renamed Visayas State University (VSU) by virtue of R.A. 9437;

**WHEREAS**, Section 7 of R.A. 9158 specifically empowers the Board of Regents of the University to “*exercise all the powers granted to the Directors of a corporation under Section 36 of Batas Pambansa Blg. 68 otherwise known as the Corporate Code of the Philippines*”;

**WHEREAS**, VSU is a CHED Center for Excellence (COE) in Agriculture and a National University in Region VIII, it is mandated to provide leadership in developing highly competitive human resource, relevant scientific knowledge, and innovative technologies to support the sustainable development of the Visayas Region in particular and the whole of the Philippines in general;

**WHEREAS**, the award was only given to the winning bidder after all the process of the bidding procedure had been observed and carried out;

**WHEREAS**, there were three bidders who submitted their bids for the contract, namely: Handlink, Inc., Pronet Systems Integrated Network Solutions, Inc., and Joebz Computer Sales and Services;

**WHEREAS**, the BAC disqualified Joebz Computer Sales and Services due to several overdue deliveries in its previous contracts with VSU;

**WHEREAS**, the BAC identified the Lowest Calculated Bids per item with Handlink, Inc. for Item 1 and Joebz Computer Sales and Services for Item 2;

**WHEREAS**, the BAC declared Handlink Inc., as the bidder with the Lowest Calculated and Responsive Bids (LCRBs) per item for the Supply and Delivery of IT Equipment for the Enhancement of ViCARP and CMIs Connectivity Infrastructure (VSU-GOODS-23-23) and recommended the approval of the award of contract to Handlink, Inc., with the total amount of **P5,556,826.62** and to recommend for approval to the VSU Board of Regents;

**WHEREAS**, the proposal was discussed and endorsed by the VSU Finance Committee during its 12 October 2023 meeting via zoom.

**Resolved as it is thereby to APPROVE BAC Resolution No. CB-21 Series of 2023 – BAC Resolution Declaring Handlink Inc. as the Bidder with LCRBs per Item and Recommending for Approval to the VSU Board of Regents the Award of Contract to the said Bidder with the Total Amount of P5,556,826.62 for the project Supply and Delivery of I.T. Equipment for the Enhancement of ViCARP & CMIs ICT Connectivity Infrastructure (VSU-GOODS-23-23).**
