BOR RESOLUTION NO. 6, s. 2014

A RESOLUTION APPROVING THE PROPOSAL FOR THE UTILIZATION OF UNIVERSITY SHARE ON INCOME FROM INCOME GENERATING PROJECTS (IGPs) FOR 2013 IN THE AMOUNT OF P1,780,083.78 FOR THE COMPLETION OF MAJOR REPAIRS OF THE VSU PAVILION AND THE CONSTRUCTION OF A KITCHEN AS APPROVED BY UNIVERSITY ADMINISTRATIVE COUNCIL (UADCO) PROVIDED THAT THE TOTAL AMOUNT CONFORMS WITH COA CIRCULARS ON THE USE OF SAVINGS OR INCOME AND SUBJECT TO EXISTING LAWS AND THE USUAL ACCOUNTING AND AUDITING RULES AND REGULATIONS AS WELL AS THE AVAILABILTY OF FUNDS

WHEREAS, Section 6 of RA 9336 (An Act Approving Funds for the Operations of the Government of the Philippines) provides, to wit: "Revolving Funds shall be established and maintained only in cases where said funds are expressly created by law or this section. Revolving funds already in existence shall continue their operations";

WHEREAS, Section 7, Paragraph (b) of R.A. 9158 empowers the Governing Board "to receive and appropriate all sums as may be provided for the support of the University in the manner it may determine, in its discretion, to carry out the purposes and functions of the University";

WHEREAS, the University Share on Income from Income Generating Projects (IGPs) for 2013 amounted to P1,780,083.00, as of 31 December 2013;

WHEREAS, the University needs said funds for the completion of the major repairs undertaken on the VSU Pavilion including the construction of a new kitchen facility;

WHEREAS, the proposal was discussed by the University Administrative Council on the occasion of the 106th UADCO Meeting held last 05 February 2014 at the Conference Room, Office of the Vice President for Administration and Finance, VSU Main Campus, City of Baybay, Leyte passed UADCO Resolution No. 5, s. 2014 approving the proposal and strongly endorsing the proposal to the VSU Board of Regents for Approval;

THEREFORE, BE IT RESOLVED AS IT IS HEREBY RESOLVED to approve the proposal for the utilization of University Share on Income from Income Generating Projects (IGPs) for 2013 in the amount of P1,780,083.78 for the completion of the major repairs undertaken on the VSU Pavillion including the construction of a new kitchen facility as recommended by the University Administrative Council provided that the amount conforms with DBM and COA Circulars on the use of savings or income and subject to existing laws and the usual accounting and auditing rules and regulations as well as the availability of funds.
