**A RESOLUTION APPROVING
THE CHANGE OF NAME OF THE
BACHELOR OF SCIENCE IN GEODETIC AND GEOMATICS
ENGINEERING (BSGGE) TO BACHELOR OF SCIENCE
IN GEODETIC ENGINEERING (BSGE) EFFECTIVE
1st SEMESTER, SY 2009-2010**

WHEREAS, Section 4, Paragraph (i) of R.A. 8292 empowers the Governing Board "to approve the curricula, institutional programs and rules of discipline drawn by the administrative and academic councils, as hereby provided";

WHEREAS, Section 10 of Republic Act No. 8292 – The Academic Council - stipulates the powers of the Academic Council to wit: "The academic council shall have the power to review and recommend the curricular offerings and rules of discipline of the university or college subject to the appropriate action of the Board of Regents/Trustees. It shall fix the requirements for the admission of students as well as for graduation and the conferment of degrees, *subject to review and/or approval of the Board of Regents/Trustees through the President of the university or college*";

WHEREAS, the PRC has almost barred VSU graduates from taking the PRC Examination because of the "*non-conformity of the degree title with the qualifications required for the examination*";


WHEREAS, the Philippine Regulations Commission (PRC) has made a ruling that "*only graduates of the Bachelor of Science in Geodetic Engineering*" programs can take the PRC Licensure Examination for Geodetic Engineers;

WHEREAS, the University Academic Council approved the proposed change of name of the Bachelor of Science in Geodetic and Geomatics Engineering (BSGGE) to Bachelor of Geodetic Engineering (BSGE) last 27 May 2009 and passed UAC Resolution No. 10, s. 2009 and has favorably recommended to the VSU Board of Regents the approval of the proposal effective 1st Semester, SY 2009-2010;




