BOR RESOLUTION NO. 08, s. 2015

A RESOLUTION APPROVING THE REQUEST OF THE VSU VILLABA CAMPUS TO UTILIZE THE REMAINING BALANCE OF CY 2014 UNAPPROPRIATED COLLECTIONS FROM FUND 164 IN THE AMOUNT OF P1,100,000.00 FOR AUGMENTATION OF MOOE AND CAPITAL OUTLAY, CY 2015 SUBJECT TO EXISTING RULES AND REGULATIONS ON THE USE OF SUCH FUNDS

WHEREAS, Republic Act 9158 converted the then Visayas State College of Agriculture (ViSCA) into a state university, the Leyte State University, on 11 August 2001 and was later renamed Visayas State University (VSU) by virtue of R.A. 9437;

WHEREAS, Section 7, Paragraph (b) of R.A. 9158 empowers the Governing Board “to receive and appropriate all sums as may be provided for the support of the University in the manner it may determine, in its discretion, to carry out the purposes and functions of the University”;

WHEREAS, Section 7, Paragraph (f) of R.A. 9158 empowers the Governing Board “to authorize the construction or repair of its buildings, machineries, equipment and other facilities and the purchase and acquisition of real and personal properties, including necessary supplies, materials and equipment...”;

WHEREAS, the VSU Villaba Campus would like to utilize said funds as follows:

A. Augmentation of MOOE Funds, to wit:

1. P 50,000.00 for purchase of office supplies for Administration for CY 2015;
2. P100,000.00 for travel and gasoline expenses for CY 2015; *and*
3. P550,000.00 for the payment of wages of Job Order (JO) employees for the 1st Quarter, CY 2015.

B. Augmentation of Capital Outlay funds, to wit:

1. P100,000.00 for the purchase of additional computers for the Computer Laboratory; *and*
2. P300,000.00 for repairs and repainting of buildings.

WHEREAS, the proposal was discussed and approved on the occasion of the 112th UADCO Meeting held last 23 February 2015 at the University Guest House, VSU Main Campus, Visca, City of Baybay, Leyte and the UADCO is strongly endorsing the proposal for Approval by the VSU Board of Regents.

THEREFORE, BE IT RESOLVED AS IT IS HEREBY RESOLVED to approve the request for the VSU Villaba Campus to *“Utilize the Remaining Balance of CY 2014 Unappropriated Collections from Fund 164 in the Amount of P1,100,000.00 for Augmentation of MOOE and Capital Outlay, CY 2015 Subject to Existing Guidelines, Rules and Regulations Onm the Use of Such Funds”*.

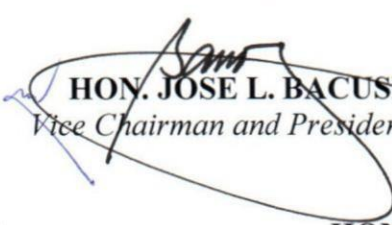
