RESOLUTION APPROVING THE EXEMPTION FROM PAYMENT OF SCHOOL FEES BY 4th YEAR BEED AND BSED STUDENTS TAKING PrED 161 (ASSESSMENT OF STUDENT LEARNING 2) IN THE 2nd SEMESTER, SCHOOL YEAR 2008-2009

WHEREAS, the Leyte State University was created by virtue of Republic Act 9158 which converted the then Visayas State College of Agriculture (ViSCA) into a state university last 11 August 2001 and was later renamed Visayas State University (VSU) by virtue of R.A. 9437;

WHEREAS, Section 7 of R.A. 9158 specifically empowers the Board of Regents of the University to exercise all the powers granted to the Board of Directors of a corporation under Section 36 of Batas Pambansa Blg. 68, otherwise known as the Corporate Code of the Philippines;

WHEREAS, among other powers granted to the Board of Regents is the power "to fix the tuition fees and other necessary school fees and charges such as, but not limited to, matriculation fees, graduation fees and laboratory fees, as it may deem proper and reasonable to impose after due consultations with the involved sectors" as stipulated in Item (d), Section 7 of R.A. 9158;

WHEREAS, the Professional Regulations Commission (PRC) issued PRC Resolution No. 7, s. 2008 last June 2008 "requiring examinees of the Licensure Examination for Teachers (LET) starting in 2009 to have taken Assessment of Student Learning I and Assessment of Student Learning 2 (at three units/course)";

WHEREAS, the 4th Year BEEd and BSEG students have only taken one 3-unit course ProfEd 134 (Tests, Measurement and Evaluation) in the old curricula which is an equivalent course of PrEd 146 (Assessment of Student Learning 1) in the revised curricula.;

WHEREAS, the University Curriculum Committee has approved the offering of PrEd 161 (Assessment of Student Learning 2) as an additional course to satisfy the PRC requirement;

WHEREAS, the University Administrative Council unanimously approved the grant of tuition fee exemption for the 4th Year BEEd and BSEd students who will take the course in the 2nd Semester, School Year 2008-2009 on the occasion of its 72nd UADCO Meeting held last 19 September at the 2nd Floor of the Center for Continuing Education, VSU Main Campus, Visca, City of Baybay, Leyte.

THEREFORE, BE IT RESOLVED AS IT IS HEREBY RESOLVED to approve the exemption from the payment of appropriate school fees covering PrEd 161 (Assessment of Student Learning 2) which will be taken by 4th Year BEEd and BSEd students this coming 2nd Semester, School Year 2008-2009.

Resolution on Exemption from Payment of Appropriate School Fees in PrEd. 161by 4^{th} Year BEEd and BSEd students, 2^{nd} Semester, SY 2008-2009

Proposal to EXEMPT THE BEED AND BSED FOURTH YEAR STUDENTS OF SECOND SEMESTER, SY 2008-2009, FROM PAYING THE TUITION FEE OF Pred 161 (ASSESSMENT OF STUDENT LEARNING 2)

Rationale:

Proposal:

ProfEd 200 (Student Teaching) which is 12 units is the final course requirement for BEED and BSED students. The additional course, PrEd 161 (Assessment of Student Learning 2), will be enrolled as Crash Course for 54 hours by the current fourth year education students before they will be deployed for student teaching this coming second semester SY 2008-09 (see attached schedule).

Since parents are prepared to pay only the tuition fee of their children for Student Teaching, and because PrEd 161 forms a part of the workload of faculty members who will handle the course, it is hereby proposed that the current fourth year BEED and BSED students will not be required to pay the tuition fee of the additional course PrEd 161 (Assessment of Student Learning 2), as the University was not able to implement the revised BEED and BSED curricula mandated by CHED Memo Order 30, series of 2004 effective SY 2005-06 due to some reasons during the development of the curricula.
