**BOR RESOLUTION NO. 101, s. 2011**

**A RESOLUTION APPROVING THE DESIGNATION OF  
MS. VELMA P. BONTUYAN TO BE THE NEW ELECTRONIC  
DOCUMENTARY STAMP TAX (eDST) ACCOUNT OWNER WITH  
THE BUREAU OF INTERNAL REVENUE (BIR), IN LIEU OF MS. CORAZON  
U. NUEVO ON BEHALF OF THE UNIVERSITY PURSUANT TO REVENUE  
REGULATION NO. 7-2009 DATED 29 JUNE 2010**

**WHEREAS**, the Leyte State University was created by virtue of Republic Act 9158 which converted the then Visayas State College of Agriculture (ViSCA) into a state university last 11 August 2001 which was later renamed Visayas State University (VSU) by virtue of R.A. 9437;

**WHEREAS**, Section 7 of R.A. 9158 specifically empowers the Board of Regents of the University to "*exercise all the powers granted to the Board of Directors of a corporation under Section 36 of Batas Pambansa Blg. 68, otherwise known as the Corporate Code of the Philippines*";

**WHEREAS**, Section 7, Paragraph (g) of R.A. 9158 empowers the Governing Board "*to appoint, upon the recommendation of the President of the University, vice-presidents, deans, directors, heads of department, faculty members and other officials and employees of the University*";

**WHEREAS**, the Bureau of Internal Revenue has issued Revenue Regulation (RR) No. 7-2009 dated 29 June 2010 mandating the implementation of the Electronic Documentary Stamp Tax (eDST) System replacing the use of the Documentary Stamp Electronic Imprinting Machine (DSEIMs) with the Electronic Documentary Stamp (eDST) system;

**WHEREAS**, the BIR requires the use of the eDST system in the payment /remittance of documentary stamp tax liabilities and the affixture of the prescribed documentary stamp tax on taxable documents;

**WHEREAS**, the BIR has required the Visayas State University to enroll in the Electronic Documentary Stamp Tax ((eDST) System;

**WHEREAS**, VSU Board of Regents passed BOR Resolution No. 65, s. 2011 dated 28 July 2011 on the occasion of the 53<sup>rd</sup> BOR Meeting held at the Office of the President, Visayas State University Visca, City of Baybay, Leyte which Approved the designation of Ms. Corazon U. Nuevo, then the University Cashier, as she was the person responsible for the collection of payments of documentary stamps;

**WHEREAS**, the Director for Finance of the Visayas State University, Ms. Roberta C. Lemos, has recommended the designation of the new University Cashier, Ms. Velma P. Bontuyan, as the new eDST Account Owner with the Bureau of Internal Revenue, on behalf of the University;


**THEREFORE, BE IT RESOLVED AS IT IS HEREBY RESOLVED** to approve the designation of Ms. Velma P. Bontuyan to be the new Electronic Documentary Stamp Tax (eDST) Account Owner with the Bureau of Internal Revenue, *in lieu* of Ms. Corazon U. Nuevo, on behalf of the University pursuant to Revenue Regulation No. 7-2009 dated 29 June 2010.




