A RESOLUTION APPROVING THE PROPOSED CONTACT HOURS FOR ADMINISTRATIVE RESPONSIBILITIES AND CONVERSION OF WORKLOAD CREDIT UNITS INTO NUMBER OF HOURS

WHEREAS, members of the academic faculty have traditionally been looked upon as potential leaders of the institution;

WHEREAS, the Leyte State University routinely designates academic faculty to fill-in certain administrative positions to be able to effectively and efficiently run the organization;

WHEREAS, the designated academic faculty members perform their administrative functions over and above their academic functions of instruction, research, extension and production;

WHEREAS, in the past, these academic faculty members have been provided with a small honorarium as a way of remunerating them for accepting the added administrative responsibility;

WHEREAS, Budget Circular No. 2003-5 restricts the giving of honorarium to academic faculty members holding designated positions;

WHEREAS, there is a need to remunerate academic faculty members holding designated positions without transgressing Budget Circular No. 2003-5;

WHEREAS, the University Administrative Council has discussed and approved the proposal for the number of contact hours for administrative responsibilities and the conversion of workload credit units into number of hours; and has strongly endorsed the proposal for the final review and approval by the LSU Board of Regents.

THEREFORE, BE IT RESOLVED AS IT IS HEREBY RESOLVED to approve the proposed Contact Hours for Administrative Responsibilities and Conversion of Workload Credit Units into Number of Hours.
