BOR RESOLUTION NO. 108, s. 2016

A RESOLUTION APPROVING THE PROPOSAL OF THE VSU TOLOSA FOR OBLIGATIONAL AUTHORITY FOR THE USE OF INCOME FOR CALENDAR YEAR 2016 AS SUPPLEMENTAL BUDGET OF SPECIAL TRUST FUND (FUND 164) IN THE AMOUNT OF P1,404,990.40 FOR AUGMENTATION OF CAPITAL OUTLAY AND MAINTENANCE AND OTHER OPERATING BUDGET SUBJECT TO EXISTING POLICIES, RULES AND GUIDELINES ON THIS MATTER

WHEREAS, the Leyte State University was created by virtue of Republic Act 9158 which converted the then Visayas State College of Agriculture (ViSCA) into a state university last 11 August 2001 which was later renamed Visayas State University (VSU) by virtue of R.A. 9437;

WHEREAS, Section 7 of R.A. 9158 specifically empowers the Board of Regents of the University to "exercise all the powers granted to the Board of Directors of a corporation under Section 36 of Batas Pambansa Blg. 68, otherwise known as the Corporate Code of the Philippines";

WHEREAS, Section 7, Paragraph (b) of R.A. 9158 empowers the Governing Board "to receive and appropriate all sums as may be provided for the support of the University in the manner it may determine, in its discretion, to carry out the purposes and functions of the University";

WHEREAS, VSU Tolosa needs a supplemental budget in the amount of P1,404,990.40 in order for it to operate all of its programs and that it has determined for itself that the actual collections for Special Trust Fund for the period 01 January 2016 until 31 October 2016 net of disbursements amounts to P3,291,622.17;

WHEREAS, the VSU Tolosa would like to utilize said funds as follows:

- A. Augmentation of Capital Outlay Funds (P200,000.00), to wit:
 - 1. Medical Equipment (**P200,000.00**)
 - a. Sports Equipment P 55,000.00.
- B. Augmentation of MOOE Funds (P1,204,990.40), to wit:
 - 1. Travelling Expenses P51,131.51
 - 2. Accountable Forms P200,000.00
 - 3. Other Supplies and Materials P510,632.41
 - 4. Water Expense 128,122.27
 - 5. Electricity Expense 117,779.21
 - 6. Internet Expense P75,292.20
 - 7. Other MOOE P122,031.80
