BOR RESOLUTION NO. 21, s. 2014

**A RESOLUTION COURSED THROUGH A REFERENDUM APPROVING THE
REVISED ACADEMIC CALENDARS FOR SUMMER, SY 2013-2014
OF THE VISAYAS STATE UNIVERSITY-SYSTEM**

WHEREAS, Section 7, Paragraph (a) of R.A. 9158 empowers the Governing Board “to enact rules and regulations as may be necessary to carry out the purposes and functions of the University”;

WHEREAS, Section 10 of R.A. 9158 indicates that it is the duty of the Administrative Council “to review and recommend to the Board policies governing the administration, management and development planning of the University”;

WHEREAS, the VSU Board of Regents unanimously approved the revised VSU Academic Calendars for SY 2013-2014 with the passage of BOR Resolution No. 66, s. 2013 last 11 December 2013 after taking into consideration the stoppage of classes in all campuses of the University-system on account of damage wrought by Super-Typhoon Yolanda and in order to pave the way for the immediate repair of damaged buildings and other critical infrastructure;

WHEREAS, the University administration has decided to move forward the opening of classes for the coming 1st Semester, SY 2014-2015 from 03 August 2014 to 16 June 2014 to synchronize it with the opening of classes of other HEIs including SUCs in the Visayas Region;

WHEREAS, it is also necessary to move forward the opening of the Summer classes for SY 2013-2014 in the Main Campus and External Campuses to enable the University system to re-synchronize its academic calendar to enable all campuses to start the 1st Semester, SY 2014-2015 by 16 June 2014;

WHEREAS, the proposed Revised Academic Calendars for Summer, SY 2013-2014 presented for discussion and approved on the occasion of the 107th UADCO Meeting held last 02 April 2014 at the Conference Room, Office of the Vice President for Administration and Finance, Administration Building, VSU Main Campus, Visca, City of Baybay, Leyte and the UADCO approved the new schedule of Summer classes for all campuses of the VSU-system;

WHEREAS, the University President has reviewed the proposed Revised Calendars for Summer, SY 2013-2014 and is endorsing the same to the Board of Regents for **Approval**.






