**A RESOLUTION APPROVING THE REORGANIZATION  
OF THE OFFICE OF THE VICE PRESIDENT FOR  
DEVELOPMENT AND EXTERNAL AFFAIRS**

**WHEREAS**, there is a need to further streamline the functions of the Office of the Vice President for Development and External Affairs (OVPDEA);

**WHEREAS**, there is a need to transfer the Office of Auxiliary Services from the OVPDEA to the Office of the Vice President for Administration and Finance;

**WHEREAS**, there is a need to create the Office for Development and Planning which will be responsible for the Planning Office, Management Information System (MIS) and the Evaluation Office;

**WHEREAS**, there is an urgent need to create the Office for Institutional Linkage which will be responsible for the Information Office, Radio Station DYAC, Alumni and Community Relation Office (ACRO) and the Fund Sourcing Committee;

**WHEREAS**, the University Administrative Council met on 16 January 2007 on the occasion of the 61<sup>st</sup> UADCO Meeting and was amenable to the proposal to reorganize the Office of the Vice President for Development and External Affairs.

**THEREFORE, BE IT RESOLVED AS IT IS HEREBY RESOLVED** to approve the proposal to reorganize the Office of the Vice President for Development and External Affairs;




