WHEREAS, the VISAYAS STATE UNIVERSITY through its Bids and Awards Committee posted on 5 February 2020 in the PhilGEPS, VSU Website's Transparency Seal and in conspicuous places within the premises of the Visayas State University an Invitation to Bid for the **Supply and Delivery of Laboratory Furniture for RQAT (GOODS – 20 – 14) for the Total Value (ABC) of Four Million Pesos (Php 4,000,000.00);**

WHEREAS, the source of funds was from GAA of 2020 and allotted for the Project "Purchase of Equipment/(Enhancing Educational Experience of Students by Complying with the RQAT Recommendation and CHED CMO)" for VSU Isabel and certified for funds availability by the Budget officer, Ms. Myrna Pancito;

WHEREAS, on the day of bid opening, 2 March 2020 at 9:00 AM, seven bidder offered bids: Gemit Laboratory Furniture and Equipment Corporation; Yana Chemodities, Incorporated; Elite Scientific & Diagnostic Int'l Supplies Corporation; ILAB Turnkey Industries, Inc.; Hytec Power, Inc. and Aspen Multi-system Corporation;

WHEREAS, the Items under the LOT Bidding consisted of four (4) units of Chemistry Laboratory Table with unit price of Php 500,000.00 and four (4) units of Chemistry Demonstration Table (Movable) at a unit price of Php 250,000.00;

WHEREAS, Yana Chemodities, Incorporated offered a total value of Php 1,686,400.00 but did not comply the required thickness of 20 mm for the Chemistry Laboratory Table;

WHEREAS, the Closest Lowest Calculated Responsive Bid was from ILAB Turnkey Industries, Incorporated with the offer of Php 1,723,403.87 complying with all specifications except for the absence of a statement of regarding the movability of the Chemistry Demonstration Table;

WHEREAS, upon inspection of the pictures provided for the Chemistry Demonstration Table, the table offered by ILAB Turnkey Industries could be easily transferred by lifting the table as it is not fixed on the floor;



NOW, THEREFORE, based on the above premises, we the Members of the Bids and Awards Committee, **HEREBY RESOLVE**, as it is **RESOLVED** to:

1. Recommend to the HOPE to Award the Lot Purchase of Chemistry Laboratory Tables and the Chemistry Demonstration Tables to ILAB Turnkey Laboratories, Incorporated for a total value of One Million Seven Hundred Twenty-Three Thousand Four Hundred Three and 87/100 Pesos (Php 1,723,403.87).
