A RESOLUTION APPROVING THE REQUEST OF PRESIDENT EDGARDO E. TULIN FOR AUTHORITY TO TRAVEL TO THE JAPAN FOR THE PERIOD 22 JANUARY 2017 UNTIL 28 JANUARY 2017 SUBJECT TO EXISTING RULES AND REGULATIONS GOVERNING FOREIGN TRAVELS BY GOVERNMENT OFFICIALS

WHEREAS, the Commission on Higher Education (CHED) is in the process of organizing the Phil-HECS Presidential Leadership Program – International Study Visit to GRIPS Japan this coming 22 January 2017 until 28 January 2017;

**WHEREAS**, President Tulin has been selected by the CHED to be one of the delegates for this international study visit;

**WHEREAS**, Section 7(t) of R.A. 9158 specifically empowers the VSU Board of Regents to "develop academic arrangements for institutional capability building with appropriate institutions and agencies, public or private, local or foreign, and to appoint experts/specialists as consultants, or visiting or exchange professors, scholars, researchers, as the case may be";

WHEREAS, the CHED has indicated that it will shoulder the local and international airfares as well as the board and lodging expenses while in Japan.

**NOW, THEREFOR, BE IT RESOLVED, AS IT IS HEREBY RESOLVED** to Approve the request of President Edgardo E. Tulin for authority to travel to Japan for the period 22-28 January 2017 *subject to* existing rules and regulations governing foreign travels by government officials.


