#### BOR RESOLUTION NO. 94, s. 2017

A RESOLUTION CONFIRMING THE CHANGE IN APPOINTMENT STATUS OF NINETEEN (19) ACADEMIC STAFF FROM TEMPORARY TO PERMANENT SUBJECT TO EXISTING RULES, REGULATIONS AND GUIDELINES GOVERNING SUCH APPOINTMENTS

WHEREAS, the Leyte State University was created by virtue of Republic Act 9158 which converted the then Visayas State College of Agriculture (ViSCA) into a state university last 11 August 2001 which was later renamed Visayas State University (VSU) by virtue of R.A. 9437;

WHEREAS, Section 4 of R.A. 9158 specifically provides that the University "shall have the general powers of a corporation as set forth in the Corporation Law. The Administration of the University and the exercise of its powers shall be vested exclusively in the Board of Regents";

**WHEREAS**, among other powers granted to the Board of Regents is the power "to fix and adjust salaries of faculty members and administrative officials and employees ..." as stipulated in Section 7, Item (h) of R.A. 9158;

WHEREAS, the Academic Personnel Board (APB) of the Visayas State University, undertook a process of screening the most qualifications of the candidates for permanency following the requirements set by the ViSCA Code and in the NBC 461 Guidelines;

WHEREAS, after due deliberation, the APB determined that the nineteen (19) faculty members possess the necessary qualifications for permanency, as follows:
