PROPOSAL FOR AN INCREASE OF ATHLETIC FEE IN THE STUDENT'S COMPREHENSIVE FEE EVERY SEMESTER

The Institute of Human Kinetics of the Visayas State University is committed to provide sports programs that promote and develop character, leadership, teamwork, physical skills and competitiveness. IHK is always given the task to initiate and spearhead sports activities of the university. It is also our belief that sports should be an enjoyable, dynamic and integral part of the educational process, thus, we intend to offer school based sports programs that provide students with meaningful learning opportunities outside the classroom. These sports programs are beneficial to both students and the university. These aim to develop the students' potential and to become a well-rounded individual capable of contributing their skills to a productive society. On the other hand, it is a good avenue for promoting the university in regional and national sports competition.

In 1982, when the Varsity Teams of the then Visayas State College of Agriculture (ViSCA) was given the go signal by the former President Dr. Fernando A. Bernardo to participate in the lower and higher athletic meets, it has proven its worth and we have always endeavored to be "fighting gold and green." Since then, the university participates in the Regional Competition of the State Colleges and Universities Athletic Association (SCUAA). However, there is no enough budget intended for the Physical Education classes, Intramural Games and the yearly SCUAA athletic competition. It has on this premise that we always experienced financial constraint.

In order for IHK to sustain, develop and improved the university's sports development program there is a strong need to increase the ATHLETIC FEE in the student's comprehensive fee every semester. Considering the high cost of standard sports equipment, increasing number of students in Physical Education classes, complete athletic uniforms, transportation, invitational tournaments, coaches education and training, tune-up games, vitamins and energy drinks, medicines, meals and allowances during the meet, concentration training before the meet, institutional contribution of every SUC's during SCUAA competition, maintenance of sports facilities and other supplies and materials, we strongly proposed to increase ATHLETIC FEE from ONE HUNDRED FIFTY PESOS (P150.00) to THREE HUNDRED PESOS (P300.00) to sustain our university's sports program.
