A RESOLUTION APPROVING THE PROPOSAL TO INCREASE STUDENT INCENTIVES GIVEN TO BOARD TOPNOTCHERS AND TO GIVE INCENTIVE TO DEPARTMENTS/COLLEGES PRODUCING TOPNOTCHERS SUBJECT TO EXISTING POLICIES, RULES AND GUIDELINES ON THIS MATTER

WHEREAS, the Leyte State University was created by virtue of Republic Act 9158 which converted the then Visayas State College of Agriculture (ViSCA) into a state university last 11 August 2001 which was later renamed Visayas State University (VSU) by virtue of R.A. 9437;

WHEREAS, Section 7 of R.A. 9158 specifically empowers the Board of Regents of the University to "exercise all the powers granted to the Board of Directors of a corporation under Section 36 of Batas Pambansa Blg. 68, otherwise known as the Corporate Code of the Philippines";

WHEREAS, Section 7, Paragraph (b) of R.A. 9158 empowers the Governing Board "to receive and appropriate all sums as may be provided for the support of the University in the manner it may determine, in its discretion, to carry out the purposes and functions of the University";

WHEREAS, the University has produced a number of PRC Board Topnotchers in the past several years;

WHEREAS, there is a need to increase the incentives given to PRC Board topnotchers in recognition of their efforts thus, inspire other students to strive for excellence;

WHEREAS, Departments/Colleges producing the Board topnotchers also need to be given incentives to provide them the opportunity to broaden their horizons thus inspiring them to continue striving for academic excellence;

WHEREAS, the proposal was discussed by the University Administrative Council on the occasion of the 92nd UADCO Meeting held last 13 October 2011 at the PhilRootCrops Training Hall, VSU Main Campus, City of Baybay, Leyte.

WHEREAS, the UADCO passed UADCO Resolution No. 36, s. 2011 approving the proposal and strongly endorsing the proposal to the VSU Board of Regents for Approval.

THEREFORE, BE IT RESOLVED AS IT IS HEREBY RESOLVED to approve the proposal to increase student incentive given to Board topnotchers and to give incentive to departments/colleges producing topnotchers.

PROPOSAL TO INCREASE STUDENT INCENTIVE GIVEN TO BOARD EXAMINATION TOPNOTCHERS and TO GIVE INCENTIVE TO DEPARTMENT/COLLEGE PRODUCING THE TOPNOTCHERS

(As approved by the VSU Board of Regents per Board Resolution No. 104, s. 2011, dated 20 December 2011)

RATIONALE

Graduates of selected degree programs in VSU are required to take licensure examinations. For the past years, graduates of VSU who have taken their board examinations have performed and fared very well and made it into the topnotchers landing even up to the first place, bringing recognition and prestige to the University.

With this development, VSU had recognized the achievement of these good performing graduates through giving of incentives to these topnotchers and placers. However, in order to continue to encourage or entice graduates to strive for greater academic excellence, these incentives have to be competitive and attractive. Thus, it is proposed that these incentives given to topnotchers and placers have to be increased, the existing ones have to be modified.

On the other hand, for sustained academic excellence and enthusiasm of the unit to continue to produce topnotchers, it is also suggested that it be given corresponding incentive. These incentives may be used to improve their facilities for teaching and also to boost the morale of the faculty. Another significant step would also be to broaden their horizon and perspective to continue to strive for excellence. Thus, this proposal also verbalizes the incentives for the Department or College which is showing spectacular performance.

A. Increase Incentive for Students

- First Placer 50,000.00
- Second Placer 40,000.00
- Third Placer 30,000.00
- Fourth to 10th Placers 20,000.00
- Priority in hiring for employment in VSU, subject to existing rules and regulations in hiring for faculty members

B. Incentive for Department or College producing board topnotchers

There is no existing incentive given by VSU to the Department/College that produced topnotchers. Hence the following are proposed:

- One-time MOOE Allocation for the College/Department with placers (regardless of the rank) in the amount of 100,000.00 This is to be used by the unit to improve their facilities, subject to existing COA rules and regulations
- A Plaque of Recognition will be given to unit concerned.
- For achieving 100% passing (with minimum number of takers of not less than 10), an
 incentive amount of 100,000.00 will be given to the unit. This can also be used to
 acquire additional facilities or for improvement of the unit, subject to COA rules and
 regulations
