EXCERPT FROM THE MINUTES OF THE FIRST SPECIAL BOARD OF REGENTS' MEETING OF VISAYAS STATE UNIVERSITY CONDUCTED VIA ZOOM ONLINE MEETING PLATFORM WITH MEETING ID 96632852296 ON MARCH 26, 2024 AT 10:00 AM

Upon motion duly seconded and carried, the following resolution was adopted by the VSU Board of Regents, thus:

#### **RESOLUTION NO. 37 SERIES OF 2024**

A RESOLUTION APPROVING THE RECLASSIFICATION ONE (1) FACULTY MEMBER WHO JOINED VISAYAS STATE UNIVERSITY (VSU) ON AUGUST 14, 2023 THROUGH LATERAL ENTRY FROM SOUTHERN LEYTE STATE UNIVERSITY (SLSU) AND WAS RECLASSIFIED TO ASSOCIATE PROFESSOR II WITH TWO (2) SUB-RANKS INCREMENT AS RECOMMENDED BY THE INSTITUTIONAL EVALUATION COMMITTEE OF SOUTHERN LEYTE STATE UNIVERSITY AND THE REGIONAL EVALUATION COMMITTEE (REC), PURSUANT TO DBM-CHED JC NO. 3, SERIES OF 2022 AND JC NO. 01, SERIES OF 2023, AND ENDORSING THE RECLASSIFICATION TO THE DEPARTMENT OF BUDGET AND MANAGEMENT

WHEREAS, on 18 October 2022, the Department of Budget and Management (DBM) and the Commission on Higher Education (CHED) issued Joint Circular (JC) No. 3 series of 2022 prescribing the guidelines for the implementation of the Guidelines on the Reclassification of Faculty Positions in State Universities and Colleges (SUCs), DBM-CHED JC No. 3, s. 2022;

WHEREAS, on 19 July 2023, in order to ensure uniform implementation of the evaluation criteria and guidelines across all SUCs in the country and to clarify issues and concerns that were not specifically stated in the Joint Circular, Department of Budget and Management (DBM) and the Commission on Higher Education (CHED) issued Joint Circular No. 01, series of 2023 prescribing the Supplemental Guidelines and Amendments to DBM-CHED JC No. 3, s. 2022;

**WHEREAS**, the initial implementation of the JC No. 3 shall cover the evaluation period of four (4) years faculty accomplishments from 01 July 2019 to 30 June 2023;

WHEREAS, DBM-CHED JC No. 3, s. 2022 prescribes that the Governing Board of the SUC shall have the final decision on who and to what extent the faculty will be reclassified based on Republic Act (RA) 8292, also known as the "Higher Education Modernization Act of 1997";

WHEREAS, Republic Act No. 8292, also known as the Higher Education Modernization Act of 1997, grants power to the Board of Regents to fix and adjust salaries of faculty members and administrative employees, subject to the provisions of the revised compensation and classification system and other pertinent budget and compensation laws; corollary, reclassification which would entail adjustment of the salaries of faculty members is within the exclusive power of the Board;

**WHEREAS**, faculty members of Visayas State University were evaluated by the Institutional Evaluation Committee (IEC), and the Regional Evaluation Committee (REC) based at Visayas State University (VSU) in accordance with DBM-CHED JC No. 3, s. 2022 and JC 01, series of 2023 prescribing the Supplemental Guidelines and Amendments to DBM-CHED JC No. 3, s. 2022;





WHEREAS, the President and the Chair of the Evaluation Committee affirmed that the guidelines set forth in the DBM-CHED JC 3, s. 2022, and JC 01, series of 2023 prescribing the Supplemental Guidelines and Amendments to DBM-CHED JC No. 3, s. 2022, particularly on Educational Qualification; Publications; Participation in Conferences, Seminars, and Workshops; and Membership in Professional Organizations were strictly adhered to in the evaluation process, with the implementation of additional controls to validate the submitted documents and ensure the observance of quality and excellence in the outputs of the faculty that were given corresponding credits for promotion;

**WHEREAS,** the Board carefully scrutinized the recommendation for the reclassification of faculty based on the Over-all Summary Sheet (OSS) provided by the Regional Evaluation Committee (REC);

WHEREAS, this one (1) faculty member was reclassified by the Southern Leyte State University (SLSU) Institutional Evaluation Committee (IEC) for he only joined Visayas State University (VSU) on August 14, 2023 through lateral entry;

WHEREAS; upon evaluation of his submitted documents made no appeals to the IEC of both SLSU and VSU and the REC, and thus, was recommended by the Regional Evaluation Committee (REC) to Associate Professor II with four (2) sub-ranks increment;

**WHEREAS**; faculty members with Associate Professor Ranks without relevant doctorate degrees would no longer be reclassified and promoted in the next evaluation cycles of DBM-CHED JC no.3 Series of 2022;

#### NOW THEREFORE, ON MOTION DULY MADE AND SECONDED:

**BE IT RESOLVED, AS IT IS HEREBY RESOLVED,** that upon its agreement, the Board approved the reclassification of one faculty member who only joined VSU on August 14, 2023 through lateral entry, whose specific name and rank position is contained in the list attached as Annex "A.16", who was reclassified to Associate Professor II with two (2) sub-ranks increment based on evaluation pursuant to DBM-CHED JC No. 3, s. 2022 and JC No. 01, series of 2023;

**BE IT RESOLVED FURTHER,** faculty members with Associate Professor Ranks without relevant doctorate degrees would no longer be reclassified and promoted in the next evaluation cycles of DBM-CHED JC no. 2 Series of 2022;

**RESOLVED FURTHER, AS IT IS HEREBY FURTHER RESOLVED,** that the Board endorses this one (1) faculty member for reclassification to the Department of Budget and Management (DBM) as supported by the Over-all Summary Sheet (OSS) provided by the Regional Evaluation Committee (REC);

**RESOLVED FINALLY,** that the reclassification shall be subject to existing and applicable rules and regulations.
