**BOR RESOLUTION NO. 108, s. 2015**

**WHEREAS**, Section 7, Paragraph (j) of R.A. 9158 empowers the Governing Board "*to set policies on admission and graduation of students*";

**WHEREAS**, Section 11 of Republic Act No. 9158 – The Academic Council - stipulates the powers of the Academic Council to wit: "*... review and recommend curricular offerings and fix the requirements for the admission to the University, as well as for graduation and the conferment of degrees, subject to the approval of the Board...*";

**WHEREAS**, the University Academic Council, on the occasion of its 39<sup>th</sup> University Academic Council meeting held at the University Convention Center last 12 November 2015, reviewed the list containing the lone candidate for graduation with *Latin Honors*, for the 1<sup>st</sup> Semester, SY 2015-20136

**WHEREAS**, the UAC has determined that Ms. Jenilyn E. Samaco – a student graduating with the degree of Bachelor of Secondary Education – has qualified for the *latin honor* of *Cum Laude*; and

**WHEREAS**, the UAC is strongly endorsing the lone candidate for graduation with *Latin Honors* from the Main Campus, Ms. Jenilyn E.
