WHEREAS, DBM National Budget Circular No. 589 dated 25 May 2022 on Revised Organization and Staffing Standards (OSS) for SUCs Phase 1 opens a vacancy for the Board Secretary V (SG 24) position on coterminous status at Visayas State University;

WHEREAS, Ms. Hazelle Villa – Asaldo applied for the Board Secretary V position at Visayas State University with all educational requirements, trainings, work experience, and eligibility complied;
