WHEREAS, the LSU-Isabel Campus is willing to accept the vehicle and is willing to repair and maintain transferred vehicle as best as they can;


WHEREAS, the ISRDS interposes no objection to the immediate transfer of the said ISRDS Red Toyota Land Cruiser;
