**BOR RESOLUTION NO. 18, s. 2015**

**A RESOLUTION CONFIRMING THE APPOINTMENTS OF EIGHT (8) ACADEMIC STAFF  
TO REGULAR ITEM POSITIONS (TEMPORARY STATUS), *SUBJECT TO EXISTING  
RULES AND GUIDELINES GOVERNING SUCH APPOINTMENTS  
AND EFFECTIVE ON THE DATES INDICATED***

**WHEREAS**, the Leyte State University was created by virtue of Republic Act 9158 which converted the then Visayas State College of Agriculture (ViSCA) into a state university last 11 August 2001 which was later renamed Visayas State University (VSU) by virtue of R.A. 9437;

**WHEREAS**, Section 4 of R.A. 9158 specifically provides that the University “*shall have the general powers of a corporation as set forth in the Corporation Law. The Administration of the University and the exercise of its powers shall be vested exclusively in the Board of Regents*”;

**WHEREAS**, Section 7, Item (h) of R.A. 9158 grants powers to the Board of Regents “*to fix and adjust salaries of faculty members and administrative officials and employees*”;

**WHEREAS**, the Academic Personnel Board (APB) of the Visayas State University, undertook a process of screening the qualifications of the candidates for permanency following the requirements set by the ViSCA Code and based on NBC 461 printouts;

**WHEREAS**, after due deliberation, the APB determined that the following academic staff now possesses the necessary qualifications for permanency, to wit:
