A RESOLUTION APPROVING THE CHANGE OF NAME OF THE FARM AND RESOURCE MANAGEMENT INSTITUTE TO ECO- FARM AND RESOURCE MANAGEMENT INSTITUTE

WHEREAS, the Leyte State University was created by virtue of Republic Act 9158 which converted the then Visayas State College of Agriculture (ViSCA) into a state university last 11 August 2001 and was later renamed Visayas State University (VSU) by virtue of R.A. 9437;

WHEREAS, Section 7 of R.A. 9158 specifically empowers the Board of Regents of the University to exercise all the powers granted to the Board of Directors of a corporation under Section 36 of Batas Pambansa Blg. 68, otherwise known as the Corporate Code of the Philippines;

WHEREAS, among other powers granted to the Board of Regents is the power "to establish research and extension centers of the University where such will promote the development of the latter" as stipulated in Item (m), Section 7 of R.A. 9158;

WHEREAS, the Farm and Resource Management Institute also known by its acronym FARMI, has found it imperative to emphasize its new mandate on sustainable and organic agriculture;

WHEREAS, such a change in the mandate of the FARMI necessitates the appropriate modification of its institutional name by adding the word ECO to its original institutional name and the consequent modification of its logo;

WHEREAS, the University Administrative Council unanimously approved "the change in name of the Farm and Resource Management Institute (FARMI) to Eco-Farm and Resource Management Institute (Eco-FARMI)" during the 72nd UADCO Meeting held last 19 September at the 2nd Floor of the Center for Continuing Education, VSU Main Campus, Visca, City of Baybay, Leyte.

THEREFORE, BE IT RESOLVED AS IT IS HEREBY RESOLVED to approve the change in name of the Farm and Resource Management Institute (FARMI) to Eco-Farm and Resource Management Institute (Eco-FARMI).
