**A RESOLUTION REQUESTING THE BOARD OF REGENTS

WHEREAS, Section 7, Paragraph (j) of R.A. 9158 empowers the Governing Board "*to set policies on admission and graduation of students*";

WHEREAS, Section 11 of Republic Act No. 9158 – The Academic Council - stipulates the powers of the Academic Council to wit: "... *review and recommend curricular offerings and fix the requirements for the admission to the University, as well as for graduation and the conferment of degrees, subject to the approval of the Board*...";

WHEREAS, the University Academic Council, in a Special UAC Meeting held last 14 April 2011, has carefully deliberated the request of the College of Nursing on the conferment of two (2) of its graduating BS Nursing students this coming 06 June 2011;






