**BOR RESOLUTION NO. 72, s. 2014**

**A RESOLUTION CONFIRMING THE NEW CASUAL AND CONTRACTUAL APPOINTMENTS OF TWO (2) ADMINISTRATIVE STAFF EFFECTIVE ON THE DATES INDICATED, *SUBJECT TO* EXISTING POLICIES, RULES AND GUIDELINES ON SUCH APPOINTMENTS**

**WHEREAS**, the Leyte State University was created by virtue of Republic Act 9158 which converted the then Visayas State College of Agriculture (ViSCA) into a state university last 11 August 2001 and was later renamed Visayas State University (VSU) by virtue of R.A. 9437;

**WHEREAS**, Section 4 of R.A. 9158 specifically provides that the University “*shall have the general powers of a corporation as set forth in the Corporation Law. The Administration of the University and the exercise of its powers shall be vested exclusively in the Board of Regents*”;

**WHEREAS**, among other powers granted to the Board of Regents is the power “*to appoint, upon the recommendation of the President of the University ... faculty members and other officials and employees of the University.*” as stipulated in Section 7, Item (g) of R.A. 9158;

**WHEREAS**, the University requires the services of casual and contractual administrative employees to be able to carry out its mandate as an institution of higher learning;

**WHEREAS**, the Human Resource and Management Office (HRMO) has gone over the list of employees who are recommended for renewal for the period 01 July 2014 to 31 December 2014 *without prejudice to renewal of appointment from 01 January 2015 until 30 June 2015, subject to* the availability of funds;

**WHEREAS**, the Governing Board, is convinced that the recommendations of the HRMO adheres to thrust of government that only the best and the most fit should be in the government service;

**THEREFORE, BE IT RESOLVED AS IT IS HEREBY RESOLVED** to approve the new appointments of casual and contractual administrative employees in the VSU Main Campus, effective on the dates indicated:




