**A RESOLUTION AUTHORIZING VSU PRESIDENT
DR. JOSE L. BACUSMO TO DESIGNATE DR. EDGARDO E. TULIN, VICE-
PRESIDENT FOR PLANNING AND RESOURCE GENERATION, AS
OFFICER-IN-CHARGE OF THE VISAYAS STATE UNIVERSITY
WHILE THE PRESIDENT IS ON OFFICIAL TRAVEL TO GERMANY**

WHEREAS, the Leyte State University was created by virtue of Republic Act 9158 which converted the then Visayas State College of Agriculture (ViSCA) into a state university last 11 August 2001 which was later renamed Visayas State University (VSU) by virtue of R.A. 9437;

WHEREAS, Section 7 of R.A. 9158 specifically empowers the Board of Regents of the University to "*exercise all the powers granted to the Board of Directors of a corporation under Section 36 of Batas Pambansa Blg. 68, otherwise known as the Corporate Code of the Philippines*";

WHEREAS, Dr. Jose L. Bacusmo, President, Visayas State College of Agriculture has been invited by the Centre of Agriculture in the Tropics and the Sub-Tropics of the University of Hohenheim; and


WHEREAS, the University President is requesting that he be allowed to designate Dr. Edgardo E. Tulin, Vice-President for Planning and Resource Generation, as Officer-in-Charge of the Visayas State University for the duration of his travel to Germany.




