BOR RESOLUTION NO. 32 s. 2007

A RESOLUTION APPROVING THE CONSTRUCTION OF SUN CELLULAR CELL SITE TOWER WITHIN LEYTE STATE UNIVERSITY PROPERTY

WHEREAS, Section 4, Paragraph (r) of R.A. 8292 empowers the Governing Board "to enter into joint ventures with business and industry for the profitable development and management of the economic assets of the college or university, the proceeds from which to be used for the development and strengthening of the college or university";

WHEREAS, DIGITEL MOBILE PHIL., Inc., owner and operator of Sun Cellular has signified its intention to construct a cell site tower, measuring 20 meters by 20 meters, within LSU property;

WHEREAS, the University has in its possession, land upon which a cell site tower can be constructed;

WHEREAS, the identified parcel of land is currently utilized as a paddock where napier grass is grown for cut and carry operation;

WHEREAS, the identified area is far from existing offices and housing complexes of faculty, staff and students and of the neighboring barangay;

WHEREAS, DIGITEL/Sun Cellular signified its intent to lease said area of land (400 square meters) for the sum of Php15,000.00 per month with a monthly rental escalation of 4.50% after the first four years of the contract for a definite period of ten (10) years renewable for another five (5) years;

WHEREAS, the University Administrative Council met on 16 January 2007 on the occasion of the 61st UADCO Meeting and was amenable to the proposal of Sun Cellular/Ericsson Telecommunications, Inc. provided that it will be located far from the populated areas of the University or at the pasture area of the Department of Animal Science;

THEREFORE, BE IT RESOLVED AS IT IS HEREBY RESOLVED to approve the construction of the Sun Cellular/Ericsson Telecommunications Inc. Cell Site within LSU Propoerty provided that it is constructed far from populated areas of the University or at the pasture area of the Department of Animal Science.
