A RESOLUTION APPROVING THE REQUEST OF DR. ANA MARQUIZA M. QUILICOT FOR AUTHORITY TO TRAVEL TO CROATIA TO PRESENT A PAPER ENTITLED: “*Chlamydia gallinacea* IN FREE-RANGE CHICKEN FLOCKS IN CROATIA” IN THE 8TH INTERNATIONAL CONGRESS VETERINARY SCIENCE AND PROFESSION HOSTED BY FACULTY OF VETERINARY MEDICINE, UNIVERSITY OF ZAGREB, CROATIA COVERING THE PERIOD 10-12 OCTOBER 2019

WHEREAS, the Leyte State University was created by virtue of Republic Act 9158 which converted the then Visayas State College of Agriculture (ViSCA) into a state university last 11 August 2001 which was later renamed Visayas State University (VSU) by virtue of R.A. 9437;

WHEREAS, Section 7, Paragraph (b) of R.A. 9158 empowers the Governing Board “*to receive and appropriate all sums as may be provided, for the support of the University in the manner it may determine, in its discretion, to carry out the purposes and functions of the University*”;

WHEREAS, The Governing Board passed BOR Resolution No. 25, s. 2017 entitled: Implementing Rules and Regulations in the Availment of Financial Support from the Faculty Development Fund effective SY 2017-2018 which provides financial support to the faculty in the following activities: 1) paper presentation in local, regional, national and international professional and scientific fora; 2) participation in relevant trainings, short courses, conferences, conventions, seminars, workshops, and symposia;

WHEREAS, the Office of the CHED Chairperson issued an Unnumbered CHED Memorandum dated 24 July 2018, on the subject: Guidelines in Securing Authority to Travel Abroad for State Universities and Colleges;

WHEREAS, the said Unnumbered CHED Memorandum requires the following: 1) Assessment of the International Conference/Meeting issued by the International Affairs Office Staff – CHED Central Office; and 2) Board of Regents’ Resolution;

WHEREAS, Dr. Ana Marquiza M. Quilicot will be presenting a paper entitled: “*Chlamydia gallinacea* in Free-Range Chicken Flocks in Croatia” on the occasion of the 8th International Congress Veterinary Science and Profession hosted by the Faculty of Veterinary Medicine, University of Zagreb, Croatia on 10-12 October 2019;

WHEREAS, Dr. Ana Marquiza M. Quilicot was issued by the CHED IAS, a joint Certification with Reference No. 19-9-2657 dated 19 September 2019 pursuant to the Memorandum from the Office-In-Charge dated 24 July 2018 titled: “**Guidelines for Securing Authority to Travel Abroad for State Universities and Colleges**”;

WHEREAS, the Faculty Development Fund, Visayas State University will be used to defray the cost of Dr. Ana Marquiza's travel to Croatia in the amount of not more than P50,000.00 plus US\$1,000.00 plus the Registration Fee of P6,000.00;




