**A RESOLUTION APPROVING
THE SABBATICAL LEAVE APPLICATION

01 NOVEMBER 2012 UNTIL 31 OCTOBER 2013 PROVIDED THAT

WHEREAS, Dr. Rotacio S. Gravoso, Professor III, of the Department of Development Communication, College of Agriculture, Visayas State University, City of Baybay, Leyte has expressed his desire to conduct a research entitled "*Behavioral Response to Climate Information by Farmers in Vulnerable Communities in Leyte*";

WHEREAS, Dr. Rotacio S. Gravoso is proposing to spend six (6) months – *01 December 2012 to 30 May 2013* – at the Catholic University of Leuven, Belgium as a Post-Doctoral Fellow and the remaining five (5) months – *01 June 2013 to 31 October 2013* - in the Philippines to write the research reports and journal articles;


WHEREAS, the Governing Board thoroughly discussed the merits of the proposal and found it in order.
