### BOR RESOLUTION NO. 153, s. 2020

A RESOLUTION COURSED THROUGH REFERENDUM APPROVING THE ENDORSEMENT TO THE COMMISSON ON HIGHER EDUCATION OF THE DEPARTMENT OF DEVELOMENT COMMUNICATION'S REQUEST FOR THE REALIGNMENT TO USE UP THE REMAINING MONEY OF THE CHED-COD PROJECT AND THE EXTENSION OF THE PROJECT FROM MARCH 2020 TO DECEMBER 2020

WHEREAS, the Leyte State University was created by virtue of Republic Act 9158 which converted the then Visayas State College of Agriculture (ViSCA) into a state university last 11 August 2001 which was later renamed Visayas State University (VSU) by virtue of R.A. 9437;

**WHEREAS,** Section 7 of R.A. 9158 specifically empowers the Board of Regents of the University to "exercise all the powers granted to the Directors of a corporation under Section 36 of Batas Pambansa Blg. 68 otherwise known as the Corporate Code of the Philippines";

**WHEREAS**, Paragraph (b), Section 7 of R.A. 9158 provides: "To receive and appropriate all sums as may be provided, for the support of the University in the manner it may determine, in its discretion, to carry out the purposes and functions of the University";

**WHEREAS**, the Commission on Higher Education (CHED) funded the CHED Center for Excellence (COD) of VSU's Department of Development Communication (DDC) in the amount of One Million Three Hundred Sixty Three Thousand Three Hundred Sixty Five Pesos (P1,363,365.00);

WHEREAS, according to the VSU Accounting Office, the DDC CHED-COD grant has still the remaining amount of Three Hundred Eleven Thousand Seven Hundred Ninety Three Pesos and Fifty One Centavos (P311,793.51) from MOOE and for the upgrade of DDC facilities where DDC intends to utilize the money to purchase office window blinds to be installed at DDC/DYDC to shield our faculty and staff from the direct heat of the sun and protect our air-conditioner units from severe hot temperature outside of the offices and studios;

**WHEREAS**, the DDC requests for the VSU Board of Regents' (BOR) endorsement approval to CHED on their requests for the realignment of their CHED-COD remaining money and extension of the CHED-COD project from March 2020 to December 2020 finish their communication research activities;

**WHEREAS,** after scrutinizing the attached documents the BOR approved and endorsed the request to the Commission on Higher Education;

**THEREFORE, BE IT RESOLVED AS IT IS HEREBY RESOLVED** to approve DDC's request for the realignment of their CHED-COD remaining money in the amount of Three Hundred Eleven Thousand Seven Hundred Ninety Three Pesos and Fifty One Centavos (**P311,793.51**) from MOOE and for upgrade of their DDC facilities and the extension of the CHED-COD project from March 2020 to December 2020 to complete their communication research activities.
