**PROPOSAL TO INCREASE SERVICE FEES IN THE
UNIVERSITY RECREATION CENTER**

Rationale:

The University Recreation Center had been designed as an integral part of the institution which will serve as source of recreation for students, staff and visitors. The importance of this project is that it becomes an avenue for relaxation; for releasing pent-up emotions; developing interests for indoor sports; above all, prevent students from going out of the campus for these same purpose.

With the conversion of this institution into a university, it is also expected that there will be an increase in student population to be served and yet the facilities available in the center have remained the same. In view of this, the Management would like to request that it be allowed to increase the charges per hour of the different games in the URC effective June 2002.

The projected short and long term plans are:

1. Purchase of:

- supplies for operation and maintenance;
- Stand fans;
- Wide Screen Flat TV including VCD player
- Equipment such as billiard balls, cloth, poles, bowling balls, pins, etc.;
- Curtains

2. Replacements of billiard cloth.

3. Manufacture of three(3) tables table tennis.

4. Repair and repainting of the University Union Building.
