WHEREAS, the proposed competency-based recruitment, selection and placement for faculty members is prepared to institutionalize recruitment and promotion of talents and hiring of persons not only with high caliber qualifications but also with excellent work values and attitudes for organizational success;

WHEREAS, the VSU strictly adheres to the principles of merit and fitness, and equality;

WHEREAS, the selection of faculty will be based on qualifications and competence to perform the duties and responsibilities of the position;

WHEREAS, there is a need to institutionalize the uniform implementation of competency-based recruitment, selection and placement of faculty members of the VSU across academic units and across campuses;

WHEREAS, the proposal was discussed and approved on the occasion of the 121st UADCO Meeting held last 24 August 2016 at 1st Floor, Center for Continuing Education (CCE), VSU Main Campus, Visca, City of Baybay, Leyte and the UADCO is strongly endorsing the proposal for Approval by the VSU Board of Regents.

THEREFORE, BE IT RESOLVED AS IT IS HEREBY RESOLVED to approve the proposed competency-based recruitment, selection and placement for faculty members of the Visayas State University.
