BOR RESOLUTION NO. 13 s. 2007

A RESOLUTION APPROVING THE INSTITUTION OF BIOLOGY COURSES AND THE MODIFICATION OF PREREQUISITE COURSES IN SUPPORT OF THE BACHELOR OF SECONDARY EDUCATION IN THE MAIN CAMPUS EFFECTIVE 1st SEMESTER SY 2007-2008

WHEREAS, Section 4, Paragraph (i) of R.A. 8292 empowers the Governing Board "to approve the curricula, institutional programs and rules of discipline drawn by the administrative and academic councils, as hereby provided";

WHEREAS, Section 10 of Republic Act No. 8292 – The Academic Council - stipulates the powers of the Academic Council to wit: "The academic council shall have the power to review and recommend the curricular offerings and rules of discipline of the university or college subject to the appropriate action of the Board of Regents/Trustees. It shall fix the requirements for the admission of students as well as for graduation and the conferment of degrees, *subject to* review and/or approval of the Board of Regents/Trustees through the President of the university or college";

WHEREAS, the Commission on Higher Education (CHED) issued CHED Memo. Order No. 30, s. 2004 dated September 2004 containing the Revised Policies and Standards for Undergraduate Teacher Education Curriculum for the purpose of rationalizing the undergraduate teacher education in the country;

WHEREAS, the College Academic Councils of the College of Education and the College of Arts and Sciences of the Main Campus have reviewed and favorably recommended to the University Academic Council the approval of the proposed biology subjects including the modification of prerequisites of some biology courses in support of the BSEd and the Doctor of Veterinary Medicine in the Main Campus;

WHEREAS, the University Academic Council met on 06 February 2007 for the purpose of reviewing the proposal and has determined that the proposal is in line with the CHED requirement and has favorably recommended to the University Board of Regents the approval of the proposal;

THEREFORE, BE IT RESOLVED AS IT IS HEREBY RESOLVED to approve the institution of biology courses and the modification of prerequisite courses in support of the Bachelor of Secondary Education and the Doctor of Veterinary Medicine in the Main Campus, effective 1st Semester, SY 2007-2008.
