# BOR RESOLUTION NO. 78, s. 2010

A REFERENDUM
ON THE ALLOCATION OF
FIFTEEN PESOS (Php15.00) FROM
THE SEMESTRAL ATHLETIC FEES PAID BY
EACH STUDENT FOR THE PERIOD COVERING
SY 2010-2011 IN SUPPORT OF THE PASUC NATIONAL OLYMPICS
TO BE HELD IN ILAGAN, ISABELA THIS COMING FEBRUARY 21-25, 2011

WHEREAS, the Leyte State University was created by virtue of Republic Act 9158 which converted the then Visayas State College of Agriculture (ViSCA) into a state university last 11 August 2001 which was later renamed Visayas State University (VSU) by virtue of R.A. 9437;

**WHEREAS**, Section 7 of R.A. 9158 specifically empowers the Board of Regents of the University to "exercise all the powers granted to the Board of Directors of a corporation under Section 36 of Batas Pambansa Blg. 68, otherwise known as the Corporate Code of the Philippines";

WHEREAS, among other powers granted to the Board of Regents is the power "to receive and appropriate all sums as may be provided, for the support of the University in the manner it may determine, in its discretion, to carry out the purposes and functions of the University" as stipulated in Section 7, Item (b) of R.A. 9158;

WHEREAS, the University is a regular member, in good standing, of the Philippine Association of State Colleges and Universities (PASUC);

**WHEREAS**, the PASUC Advisory Council, during its 03 December 2008 meeting, passed PASUC Resolution No. 5, s. 2008 "Approved the holding of a Biennial SCUAA National Olympics and the collection of P15.00 per student per semester effective 1st Semester, SY 2009-2010";

WHEREAS, the PASUC Executive Board passed PASUC Resolution No. 2, s. 2009, dated 27 January 2009 held at the Rizal Technological University, Mandaluyong City: "Approving/Confirming Resolution No. 05, s. 2008 passed by the PASUC Advisory Council during its meeting held on December 3, 2008 to wit:

Approving the collection of SCUAA Fee of FIFTEEN PESOS (Php15.00) per student per semester, effective First Semester of SY 2009-2010, *subject to*, approval of the SUC Governing Board, to fund the conduct of the SCUAA National Olympics.

Approving further that the amount collected shall be remitted by each SUC to the SCUAA National Olympics Executive Committee";

**WHEREAS**, the PASUC Executive Board has approved the holding of the 2011 SCUAA National Olympics on February 21-25, 2011 at Ilagan, Isabela with the Isabela State University as the host institution;

**WHEREAS**, the PASUC Executive Board is requesting all SUCs to "remit the SCUAA contribution of Fifteen Pesos (Php15.00) per student per semester, effective First Semester of SY 2010-2011 to PASUC National Office";

**WHEREAS**, the University Administration is proposing to source the requested amount from the existing Athletic Fee paid by each student per semester;

**WHEREAS**, the Governing Board is convinced that the request of the PASUC Executive Board is reasonable and will undoubtedly be needed to support the holding of the 2011 PASUC National Olympics.

**THEREFORE, BE IT RESOLVED AS IT IS HEREBY RESOLVED** to approve the request of the PASUC Executive Board through its PASUC Executive Board Resolution No. 2, s. 2009 for the collection and remittance of the amount of Fifteen Pesos (Php15.00) per student per semester, effective First Semester, SY 2010-2011.
