BOR RESOLUTION NO. 41, s. 2019

A RESOLUTION CONFIRMING THE RENEWAL OF TEMPORARY APPOINTMENTS OF SEVENTY-FOUR (74) ACADEMIC FACULTY, VSU SYSTEM, EFFECTIVE ON THE DATES INDICATED AND SUBJECT TO EXISTING POLICIES, RULES AND GUIDELINES ON SUCH APPOINTMENTS

WHEREAS, the Leyte State University was created by virtue of Republic Act 9158 which converted the then Visayas State College of Agriculture (ViSCA) into a state university last 11 August 2001 and was later renamed Visayas State University (VSU) by virtue of R.A. 9437;

WHEREAS, Section 4 of R.A. 9158 specifically provides that the University "shall have the general powers of a corporation as set forth in the Corporation Law. The Administration of the University and the exercise of its powers shall be vested exclusively in the Board of Regents";

WHEREAS, Section 7, Paragraph (g) of R.A. 9158 empowers the Governing Board "to appoint, upon the recommendation of the President of the University, vice-presidents, deans, directors, heads of department, faculty members and other officials and employees of the University";

WHEREAS, the College Deans through the Vice President for Academic Affairs have recommended the issuance of new appointments under Temporary Status to ten academic staff;

WHEREAS, University Academic Personnel Board (APB) has gone over the qualifications of the appointees and the Human Resource Management Office (HRMO) has recommended to the University President the issuance of renewal of appointments (*temporary status*) on the 50 academic staff;

WHEREAS, the APB and the HRMO strongly recommend the renewal of appointments of these academic staff; and

WHEREAS, University President has reviewed the list and is favorably recommending to the Board of Regents the Confirmation of the new appointments of these academic staff *subject to* existing rules, regulations and guidelines governing such appointments.

THEREFORE, BE IT RESOLVED AS IT IS HEREBY RESOLVED to confirm the renewal of appointments of the 74 academic staff under Temporary Status, effective on the dates indicated.
