## BOR RESOLUTION NO. 65, s. 2014

**WHEREAS**, the UAC is strongly endorsing to the VSU Board of Regents the list of candidates for graduation for Summer, SY 2013-2014 from the VSU Main Campus, for **Confirmation**, *Subject to*, compliance by all the candidates, of all the requirements for graduation on or before the deadline indicated in the approved Academic Calendar for School Year 2013-2014.
