BOR RESOLUTION NO. 65, s. 2014

WHEREAS, Section 7, Paragraph (j) of R.A. 9158 empowers the Governing Board *“to set policies on admission and graduation of students”*;

WHEREAS, Section 11 of Republic Act No. 9158 – The Academic Council - stipulates the powers of the Academic Council to wit: *“... review and recommend curricular offerings and fix the requirements for the admission to the University, as well as for graduation and the conferment of degrees, subject to the approval of the Board...”*;

WHEREAS, the list of candidates for graduation from the different campuses of the VSU Main Campus for the Summer, SY 2013-2014 was presented to the University Academic Council on the occasion of its 37th University Academic Council Meeting held last 12 September 2014, for review;

WHEREAS, the UAC approved the list of candidates for graduation for the Summer, SY 2013-2014, VSU Main Campus;

WHEREAS, the UAC is strongly endorsing to the VSU Board of Regents the list of candidates for graduation for Summer, SY 2013-2014 from the VSU Main Campus, for **Confirmation**, *Subject to*, compliance by all the candidates, of all the requirements for graduation on or before the deadline indicated in the approved Academic Calendar for School Year 2013-2014.

THEREFORE, BE IT RESOLVED AS IT IS HEREBY RESOLVED to Confirm the list of candidates for graduation for the Summer, SY 2013-2014 from the VSU Main Campus, *Provided that*, all the candidates shall have complied with all the requirements for graduation on or before the deadline indicated in the approved Academic Calendar for School Year 2013-2014.




