BOR RESOLUTION NO. 38, s. 2019

A RESOLUTION APPROVING THE FIELDING OF TEN (10) STUDENTS FOR ON-THE-JOB-TRAINING (*OJT*) IN THE NETHERLANDS FROM 18 APRIL 2019 UNTIL 18 OCTOBER 2019 IN ACCORDANCE WITH THE MEMORANDUM OF AGREEMENT (*MOA*) ENTERED INTO BY THE VISAYAS STATE UNIVERSITY (VSU) AND THE STITCHING STAGIAIRES CEBU (SS CEBU)

WHEREAS, the Leyte State University was created by virtue of Republic Act 9158 which converted the then Visayas State College of Agriculture (ViSCA) into a state university last 11 August 2001 which was later renamed Visayas State University (VSU) by virtue of R.A. 9437:

WHEREAS, Section 7 of R.A. 9158 specifically empowers the Board of Regents of the University to exercise all the powers granted to the Board of Directors of a corporation under Section 36 of Batas Pambansa Blg. 68, otherwise known as the Corporate Code of the Philippines;

WHEREAS, among other powers granted to the Board of Regents is the power "to develop consortia and other forms of linkages with local governments, institutions and agencies, both public and private, local and foreign, in furtherance of the purposes and objectives of the University" as stipulated in Section 7, Item (s) of R.A. 9158;

WHEREAS, there is a need to expose selected VSU students enrolled in the Bachelor of Science in Agriculture (BSA) *major* in Horticulture to various modern agricultural standards, methods and technologies;

WHEREAS, the Stitching Stagiaires Cebu (SSCebu), a Foundation with principal office at Spiering Weg 1000 2136 LL Zwaanshhoek, The Netherlands, provides a program of advanced studies and training in various fields in agriculture in Holland for students enrolled in selected Universities in the Philippines;

WHEREAS, the SSCebu has the capability and the capacity to provide the needed onthe-job agricultural training to the students of VSU to enhance the students' theoretical education and practical skills as indicated in the MOA;

WHEREAS, the Governing Board, is convinced that the MOA entered into by and between the VSU and the SSCebu is imbued with public interest and contributes to the stock of knowledge needed for the advancement of science and understanding;

WHEREAS, the Board of Regents passed BOR Resolution No. 57, s. 2016 dated 23 June 2016 on the occasion of the 74th BOR Meeting held at the CHED Central Office, C.P. Garcia Avenue, UP Diliman, Diliman, Quezon City, "Approving University Policies and Guidelines on the Conduct of OJT Abroad and Student Internship Abroad Program (SIAP);

WHEREAS, the Department of Horticulture, College of Agriculture, VSU Main Campus has identified ten (10) students who have qualified to undertake their On-the-Job Training (OJT) in the Netherlands through Stitching Stagiares Cebu (SS Cebu); and

WHEREAS, the VSU Student Scholarship Committee has endorsed the applications of the ten (10) students to undertake a six-month OJT in the Netherlands.

THEREFORE, BE IT RESOLVED AS IT IS HEREBY RESOLVED to Approve the fielding of ten (10) students for OJT in the Netherlands from 18 April 2019 to 18 October 2019 in accordance with the Memorandum of Agreement entered into by and between the Visayas State University and the Stitching Stagiaires Cebu (SSCebu).
