A RESOLUTION APPROVING THE DESIGNATION OF DR. REMBERTO A. PATINDOL, VP FOR ADMINISTRATION AND FINANCE AS OFFICER-IN-CHARGE OF THE UNIVERSITY FOR THE DURATION OF THE PRESIDENT'S TRAVEL TO THE JAPAN FROM OCTOBER 2016 UNTIL 14 OCTOBER 2016 SUBJECT TO EXISTING RULES AND REGULATIONS GOVERNING POWERS THAT MAY BE EXERCISED BY AN OFFICER-IN-CHARGE

WHEREAS, the University President, Dr. Edgardo E. Tulin will be travelling to the Japan to strengthen ties between the Tokyo University of Agriculture and Technology (TUAT) and the Visayas State University this coming 10 October 2016 until 12 October 2016;

WHEREAS, President Tulin wil also be attending the 21st Asian Association of Agricultural Colleges and Universities (AAACU) General Assembly and Biennial Conference at the Tokyo University of Agriculture, Setagaya, Tokyo, Japan from 13 Octobr 2016 until 14 October 2016;

WHEREAS, there is a need to designate an Officer-In-Charge (OIC) to look after the day-to-day operations including making routine but necessary decisions so as not to unduly delay any and all operations of the University; and

WHEREAS, President Edgardo E. Tulin has filed an official memorandum designating Dr. Remberto A. Patindol, Vice-President for Administration and Finance, as Officer-In-Charge of the University for the duration of his travel to the Japan from 10 October 2016 until 14 October 2016 or until his return to the VSU Main Campus, City of Baybay, Leyte.

NOW, THEREFORE, BE IT RESOLVED, AS IT IS HEREBY RESOLVED that Dr. Remberto A. Patindol be designated as Officer-In-Charge of the University for the duration of the University President's travel to Japan this coming 10-14 October 2016 or until his return *subject to* existing rules and regulations governing powers that may be exercised by an Officer-In-Charge.
