A RESOLUTION APPROVING BAC RESOLUTION NO. CB-23 SERIES OF 2023 - BAC RESOLUTION DECLARING STONEWORKS SPECIALIST INTERNATIONAL CORPORATION AS THE BIDDER WITH SCRB AND RECOMMENDING FOR APPROVAL BY THE VSU BOARD OF REGENTS THE AWARD OF CONTRACT TO THE SAID BIDDER WITH THE TOTAL AMOUNT OF P5,500,000.00 OF THE PROJECT SUPPLY AND DELIVERY OF FIBERGLASS TANKS AND OTHER EQUIPMENT FOR MARINE HATCHERY PROJECT FOR VSU TOLOSA (VSU-GOODS-23-27)

WHEREAS, the Leyte State University was created by virtue of Republic Act 9158 which converted the then Visayas State College of Agriculture (ViSCA) into a state university last 11 August 2001 which was later renamed Visayas State University (VSU) by virtue of R.A. 9437;

WHEREAS, Section 7 of R.A. 9158 specifically empowers the Board of Regents of the University to *“exercise all the powers granted to the Directors of a corporation under Section 36 of Batas Pambansa Blg. 68 otherwise known as the Corporate Code of the Philippines”*;

WHEREAS, VSU is a CHED Center for Excellence (COE) in Agriculture and a National University in Region VIII, it is mandated to provide leadership in developing highly competitive human resource, relevant scientific knowledge, and innovative technologies to support the sustainable development of the Visayas Region in particular and the whole of the Philippines in general;

WHEREAS, the award was only given to the winning bidder after all the process of the bidding procedure had been observed and carried out;

WHEREAS, the item was opened for bidding to the public;

WHEREAS, after the publication of the invitation to bid, only one bidder purchased the bidding documents, the Stoneworks Specialists International Corporation;

WHEREAS, during the conduct of the preliminary examination of the bids, the BAC had determined that the lone bidder passed;

WHEREAS, the BAC considered the Bid quotation of the lone bidder for detailed evaluation and identified the bid as Single Calculated Bid;

WHEREAS, the BAC to the post-qualification process and on-site inspection for documents and the capacity of the bidder to deliver the deliverables to the bidder’s main office at General Trias Cavite;

WHEREAS, after the post-qualification process, the BAC declared Stoneworks Specialist International Corporation as the bidder with the Single Calculated Bid (SCB) for the supply and delivery of fiberglass tanks and other equipment for Matine Hatchery (VSU-GOODS–23-27) project;

WHEREAS, the BAC also recommended the approval of the award of the contract to Stoneworks Specialist International Corporation with the total amount of **P5,500,000.00** and also recommended the approval of the VSU Board of Regents;

WHEREAS, the proposal was discussed and deliberated during the October 12, 2023, BOR Finance Committee Meeting via Zoom and the same was endorsed by the BOR Finance Committee to the Full Board for approval.

Resolved as it is thereby to APPROVE BAC Resolution No. CB-23 Series of 2023 – BAC Resolution Declaring Stoneworks Specialist International Corporation as the Bidder with SCRB and Recommending for Approval by the VSU Board of Regents the Award of Contract to the said Bidder with the Total Amount of P5,500,000.00 of the project Supply and Delivery of Fiberglass Tanks and Other Equipment for Marine Hatchery project for VSU Tolosa (VSU-GOODS-23-27).
