A RESOLUTION CONFIRMING THE CANDIDATES FOR GRADUATION FROM THE DIFFERENT CAMPUSES OF THE VSU SYSTEM FOR THE 1ST SEMESTER, SY 2015-2016 PROVIDED, THAT ALL THE CANDIDATES SHALL HAVE COMPLIED WITH ALL THE REQUIREMENTS FOR GRADUATION ON OR BEFORE THE DEADLINE INDICATED IN THE APPROVED ACADEMIC CALENDAR FOR SY 2015-2016

WHEREAS, Section 7, Paragraph (j) of R.A. 9158 empowers the Governing Board "to set policies on admission and graduation of students";

WHEREAS, Section 11 of Republic Act No. 9158 – The Academic Council - stipulates the powers of the Academic Council to wit: "... review and recommend curricular offerings and fix the requirements for the admission to the University, as well as for graduation and the conferment of degrees, subject to the approval of the Board...";

WHEREAS, the University Academic Council, has reviewed the list of candidates for graduation from the different campuses of the VSU System for the 1st Semester, SY 2015-2016; and

WHEREAS, the UAC approved the list of candidates for graduation for the 1st Semester, SY 2015-2016 on the occasion of its 39th University Academic Council Meeting held last 12 November 2015 at the University Convention Hall, VSU Main Campus, City of Baybay, Leyte, and is strongly endorsing to the VSU Board of Regents for Confirmation, the list of candidates for graduation from all the campuses of the VSU System, *Provided*, *That* all the candidates shall have complied with all the requirements for graduation on or before the deadline indicated in the approved Academic Calendar for the 1st Semester, School Year 2015-2016.

THEREFORE, BE IT RESOLVED AS IT IS HEREBY RESOLVED to **Confirm** the list of candidates for graduation for the 1st Semester, SY 2015-2016 *Provided, That* all the candidates shall have complied with all the requirements for graduation on or before the deadline indicated in the approved Revised Academic Calendar for the 1st Semester of School Year 2015-2016.
