BOR RESOLUTION NO. 15, s. 2012

A RESOLUTION APPROVING THE TRANSFER OF DEPLOYMENT AND AWARD OF ONE (1) ADMINISTRATIVE OFFICER V POSITION FROM THE MAIN CAMPUS TO THE ISABEL CAMPUS AND ONE (1) ADMINISTRATIVE OFFICER IV POSITION FROM THE ISABEL CAMPUS TO THE MAIN CAMPUS EFFECTIVE ON THE DATES INDICATED SUBJECT TO EXISTING POLICIES, RULES AND GUIDELINES GOVERNING THE TRANSFER AND AWARD OF PLANTILLA ITEMS

WHEREAS, the Leyte State University was created by virtue of Republic Act 9158 which converted the then Visayas State College of Agriculture (ViSCA) into a state university last 11 August 2001 which was later renamed Visayas State University (VSU) by virtue of R.A. 9437;

WHEREAS, Section 4 of R.A. 9158 specifically provides that the University "*shall have the general powers of a corporation as set forth in the Corporation Law. The Administration of the University and the exercise of its powers shall be vested exclusively in the Board of Regents*";

WHEREAS, Section 7 of R.A. 8292 empowers the Board to "*exercise all the powers granted to the Board of Directors of a corporation under Section 36 of Batas Pambansa Blg. 68, otherwise known as the Corporate Code of the Philippines*";

WHEREAS, Par. 2.2, Item 2.0, Section 2.0 of CMO 18, s. 1999 dated 01 June 1999 specifies, to wit: *Upon integration, the organizational structure and staffing pattern of the integrated CSIs shall be reviewed by the DBM with reference to the organizational structure and staffing pattern of the host SUC*";

WHEREAS, the plantilla item of Administrative Officer V of the Main Campus has been left vacant due to the promotion of its former incumbent employee to a higher position while the plantilla item of Administrative Officer IV of the Isabel Campus will become vacant on account of the promotion of its incumbent employee to the position of Administrative Officer V;

WHEREAS, the Department of Budget and Management (DBM) will no longer release funds for unfilled positions beginning 01 June 2012;

WHEREAS, there is a need to swap plantilla items between the Main Campus and the Isabel Campus to be able to fill up some of the vacant plantilla positions per advice from the DBM;

WHEREAS, the Office of the Director for Administration and Human Resources Development (ODA-HRD) and the Non-Academic Personnel Board subscribes to the swapping of plantilla positions between the different campuses of the University system in the interest of efficiency, fairness and equity;

BOR Resolution No. 15, s. 2012 – A Resolution Approving the Transfer and Award of One (1) Administrative Officer V position from the Main Campus to the Isabel Campus and One (1) Administrative Officer IV position from the Isabel Campus to the Main Campus effective on the dates indicated and Subject to Existing Policies, Rules and Guidelines governing the Transfer and Award of Plantilla Items.

WHEREAS, in order to fully maximize these plantilla items, the Non-Academic Personnel Board (NAPB), during its 05 December 2011 meeting, deemed it proper that the plantilla item of Administrative Officer V be given to Ms. Myrna A. Rojas of the Isabel Campus while the plantilla item of Administrative Officer IV be given to Mr. Diosdado M. Torrecampo of the Main Campus, after it was determined that these administrative employees were the most deserving to be awarded the vacant positions;


WHEREAS, the University President has approved the swapping of positions and is endorsing the same to the Board of Regents for Approval *subject to* existing rules, regulations and guidelines governing such transfer of plantilla items.



THEREFORE, BE IT RESOLVED AS IT IS HEREBY RESOLVED to approve the award of plantilla item of *Administrative Officer V* to **ROJAS**, Myrna A, and the plantilla item of *Administrative Officer IV* to **TORRECAMPO**, Diosdado M., effective on the dates indicated.


